## No. of Prizes and Cash award prizes

There are in all 15 prizes. Besides a certificate, the cash awards are:

- First Prize (1 Nos.) Rs. 1,00,000/-
- Second Prize (2 Nos.) Rs. 50,000/- each
- Third Prize (3 Nos.) Rs. 30,000/- each
- Fourth Prize (4 Nos.) Rs. 20,000/- each
- Fifth Prize (5. Nos.) Rs. 10,000/- each

It is not mandatory that all the above 15 prizes for the award would be given.
